




Global battle death rates in state-based conflicts

# "Countries are likely to adopt an increasingly broad understanding of what constitutes an armed attack."


### Global armed conflict by type


# "The likelihood of violent extreme group acquiring and using nuclear weapons remains low but plausible."

### Number of terrorism attacks per region







### What works?


"Most of the planning I've seen in about 250 American and foreign companies is like a ritual rain dance performed at the end of the dry season to which any rain that follows is attributed.
