The University handles legacy donations on behalf of all parts of the Institution centrally, from where funds are immediately allocated out to the appropriate Department following receipt.

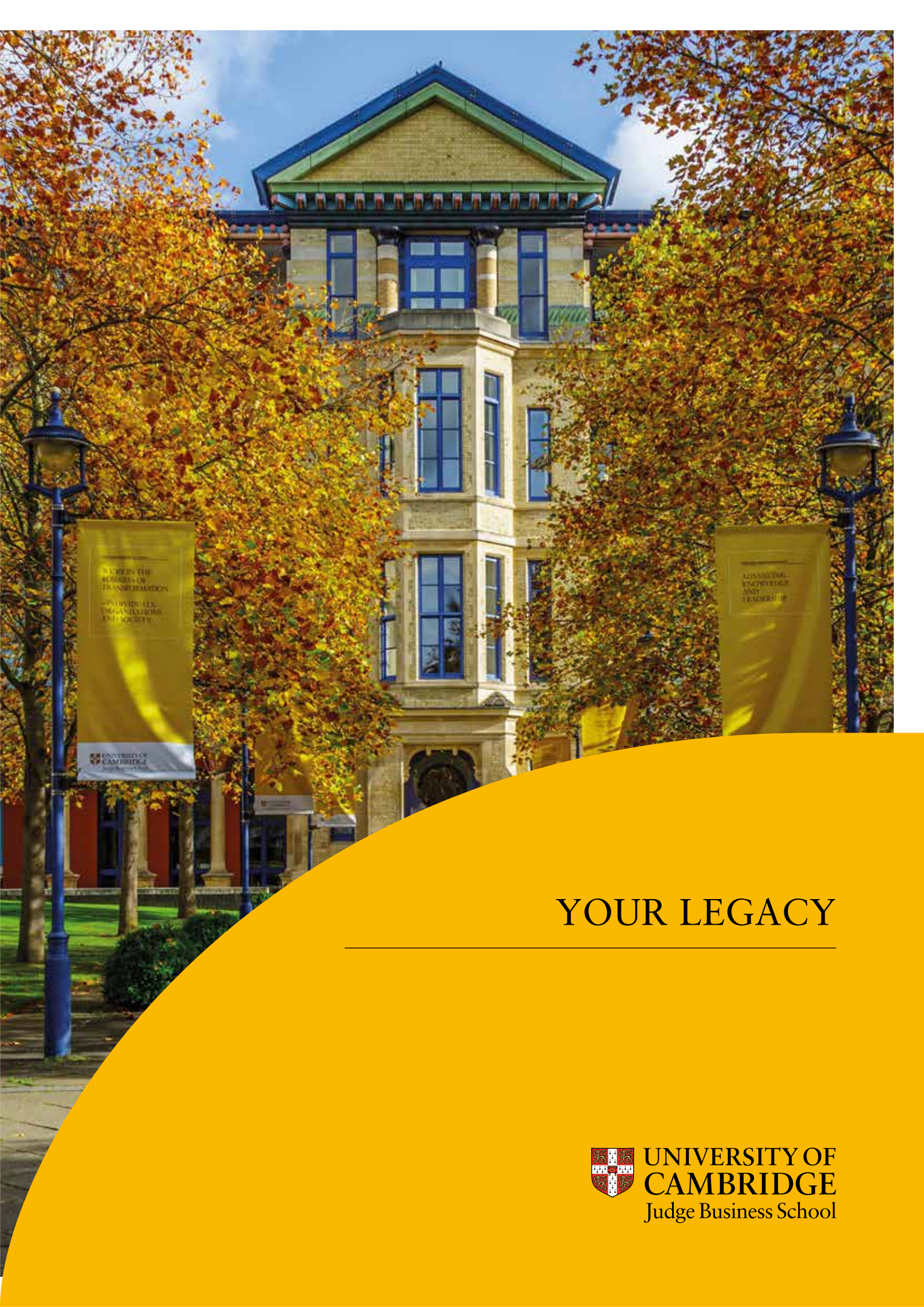
So that we can thank you properly for such a commitment during your lifetime, and to ensure that our records are accurate, we would be grateful if you could let us know if you intend to include us in your will.
