I believe when a director is appointed to a board a form has to be completed, (form 288, attached for reference). It has been suggested to me that there would be advantage in persuading Government to include an extra line on this form on the lines of, "does X know his duties as a Company Director". This would be a form of certification by the company if this is so, and involve a certification that he knew for example his legal responsibilities and arguably that the company had given him a statement of his duties.

It is too late for the recommendations this time round, and obviously a long shot, but the idea is not silly.
