# 1. Conditions where a IELTS/TOEFL test would be required:

If none of the outlined conditions in **Sections 2 & 3** apply, you are required to take either the IELTS (Academic), TOEFL iBT, or Cambridge English C2 Proficiency. IELTS One Skill Retake and TOEFL iBT Home Edition are also accepted. The minimum English language requirements for admission into the EMBA Programmes are as follows:

All tests must be taken within two years of the start date of the EMBA programme.

Applicants who narrowly miss these minimum scores may be referred to the University's Language Centre for assessment, upon admission, at the discretion of the Admissions Committee.

\*Important Note: Due to changes in test format, if you complete the TOEFL iBT after 21 January 2026, you will be asked to take an additional language assessment conducted by the University's Language Centre.



# 2. Conditions where you would not need a TOEFL/IELTS test:

An IELTS/TOEFL test is not normally required if:

- a) You are a national of and have completed secondary or tertiary education in English in a **List A country**; or
- b) You have a three-year qualification equivalent to at least a UK Bachelor's Degree that was completed in a **List A country** (except Canada\*) and with a graduation date **no more than two years** before the start date of the Executive MBA programme; or
- c) You have a three-year qualification equivalent to at least a UK Bachelor's Degree that was completed in a **List A country** (except Canada\*) AND have been living and working in a **List A country** since.

# 3. Conditions where an internal assessment by the University's Language Centre would be required:

An IELTS/TOEFL test is not normally required, however, you will be assessed upon admission internally by the University's Language Centre if:

a) You are a national of and have completed secondary or tertiary education in English in a **List B** country; or

- b) You have a two-year qualification equivalent to at least a UK Bachelor's Degree that was completed in a **List B country** and with a graduation date **no more than two years** before the start date of the Executive MBA programme; or
- c) You have a two-year qualification equivalent to at least a UK Bachelor's Degree that was completed at an institution that the University recognises as using **English as a Medium of Instruction (EMI)** at the required level for entry to Cambridge, and with a graduation date **no more than two years** before the start date of the Executive MBA programme; or
- d) You have a two-year qualification equivalent to at least a UK Bachelor's Degree in a **List A country**AND have subsequently worked for at least six months, and to within two years of the start date of the
  Executive MBA programme, in an English-speaking environment in a **List A country**. If you are given
  an offer and would like to be referred for internal assessment, you will be given a declaration
  document for your company HR to sign confirming your dates and location of employment; or
- e) You have a two-year qualification equivalent to at least a UK Bachelor's Degree in a **List A country** AND have subsequently worked for at least six months, and to within two years of the start date of the Executive MBA programme, for an international company, or an international charity, whose official operating language is English, and the role required you to use English on a regular basis. An 'international' organisation is defined as one that has offices in more than two countries. A declaration from the company is required.
- f) You sit a Cambridge C1 Advanced instead of a Cambridge C2 Proficiency: An overall score of 193 with no element lower than 185 needs to be achieved; however, applicants must also be assessed by the University Language Centre before admission can be confirmed.

Note: In exceptional cases, an applicant may be referred for a language assessment by the University's Language Centre when they do not meet any of the listed circumstances.

Please be aware that it is at the discretion of the Admissions Committee to introduce a TOEFL/IELTS test or internal Language Centre Assessment requirement at any stage in the admissions process, even if you have complied with the conditions outlined above.
