

## 2027 Programme Schedule\*

**The Global Executive MBA** is a 20-month programme delivered in a 'blended' structure, combining live online learning with in-person teaching in both Cambridge and international locations. It has been designed so students can learn around work schedules and participate from different time zones.

Over the 20-months, the teaching is comprised of 6 week-long teaching blocks: 4 are delivered in Cambridge and 2 are delivered overseas. The Live Online element entails 11 blocks of 3 half-days live online (i.e. 33 half-days of live online teaching in total).

Week-long teaching sessions begin on the morning of the first day, with the last session finishing late afternoon/evening of the final day. International study trips start in the afternoon of the first day and finish around lunchtime on the final day.

Online teaching sessions begin at 13:00 UK time on Thursdays, with the final session finishing late afternoon on the Saturdays.

As part of the assessment for the Executive MBA you are required to sit examinations. These are generally scheduled during teaching blocks. The examination dates and format will be provided when you start the programme.
